During the period from October 1, 2005 through September 30, 2006, DOS revoked 13 H-2B, and 3 H-2R visas.

CBP or ICE cancelled the visas and terminated the status of 76 aliens who were either found inadmissible at a port of entry or found deportable after admission to the United States. The revocation or termination information from CBP and ICE is not available on a month-to-month basis.

CBP or ICE cancelled the visas and terminated the status of 76 aliens who were either found inadmissible at a port of entry or found deportable after admission to the United States. The revocation or termination information from CBP and ICE is not available on a month-to-month basis.

- A total of 2,518 aliens admitted without visas by CBP (2,512 Canadians, 3 Bermudan and 3 Bahamians).



This report was prepared in accordance with Section 416(d)(2) of the American Competitiveness and Workforce Improvement Act of 1998, as amended by Section 406 of the REAL ID Act of 2005, which requires that:

Beginning in fiscal year 2007, the Secretary of Homeland Security and the Secretary of State shall submit, on an annual basis, to the Committees on the Judiciary of the House of Representatives and the Senate--

- (A) information on the countries of origin of, occupations of, and compensation paid to aliens who were issued visas or otherwise provided nonimmigrant status under section 101(a)(15)(H)(ii)(b) of the Immigration and Nationality Act (8 U.S.C. 1101(a)(15)(H)(ii)(b)) during the previous fiscal year;
- (B) the number of aliens who had such a visa or such status expires or be revoked or otherwise terminated during each month of such fiscal year; and
- (C) the number of aliens who were provided nonimmigrant status under such section during both such fiscal year and the preceding fiscal year.

This report on H-2B nonimmigrants has been compiled from information provided by the Department of State (DOS), the Department of Labor (DOL) and three components within the Department of Homeland Security (DHS): U.S. Citizenship and Immigration Services (USCIS), U.S. Customs and Border Protection (CBP), and Immigration and Customs Enforcement (ICE). Identical copies of the report will be provided to the Chairpersons and Ranking Members of the House and Senate Committees on the Judiciary and of the relevant Subcommittees.

- Admission by CBP at a port of entry as an H-2B nonimmigrant after issuance of an H-2B nonimmigrant visa by DOS;
- Admission by CBP at a port of entry as an H-2B nonimmigrant without a visa, in the case of certain Canadian, Bermudan and Bahamian residents; or
- Change of status to H-2B nonimmigrant granted by USCIS.
