



### Total Web Traffic – ALL PROPERTIES: 29,549,561 sessions (-9.1% from past month)

#### **Highlights:**


• Overall Web Traffic Remains above 2020 Levels: Despite being down over 9% from March, web traffic remained well above the average monthly traffic in 2021.

For example, in a single session, some people visit two or even all three of the domains.
