
Highlights:


- **Web Traffic Steady:** Web traffic would have likely seen a noticeable decrease this past month, but announcements on DACA and H-1B drew numerous visitors, and pushed the numbers to a modest increase instead.
- DACA Dominates Web and Social Media Activity:
 - o The two pages that saw the steepest increase in traffic on our website were both related to DACA.
 - o Two of the five top search terms entered into our site's search field in September were "daca" and "daca renewal 2017 form".
 - o Four of our five top tweets and two of our five top Facebook posts were on DACA, all but one were a part of our "DACA Facts" series of posts.
- H-1B Also Makes an Impact:
 - O While DACA made a large impact, the top <u>Facebook</u> and <u>Twitter posts</u> each dealt with the news that we had resumed premium processing for all H-1B visa petitions subject to the fiscal year 2018 cap.
- Monthly Satisfaction Scores: Our satisfaction score numbers remained steady, either remaining the same, or moving one point.






USCIS.gov Website Visitors: Percentages using desktop, mobile and tablets over time
